NOMINATIONS

Nominations are invited for: **2 x Directors - 3 year term**

Candidates must have completed a minimum of 5 years current and continuous membership.

Rule 54 (a) of the Constitution of Moorebank Sports Club Limited states:

"Subject to Rule 55 and (b) below, only Life Members, Permanent members and financial Club members who have been members for the five (5) consecutive calendar years immediately preceding the date on which they are to be elected or appointed to the Board shall be entitled to stand for and be elected or appointed to the Board".

Nominations shall be in writing and signed by any two (2) Club members, Permanent members or Life members of the Club as at **7.00pm, Sunday 11th October 2020** (other than the candidate) and by the candidate who shall signify his/her consent to the nomination. No financial member may nominate more candidates than the number to be elected.

LODGEMENT OF NOMINATIONS

Nominations must be lodged by:

A nomination cannot be withdrawn after this time and any defect must be rectified before this time.

A draw will be conducted at the Club at **7.15pm, Sunday 11th October 2020** to determine the order of nominated candidates' names on the ballot paper. Candidates or their representatives are invited to witness the draw.
